



# Riverside Lawn Care (RLC) – Terms of Service

Welcome to Riverside Lawn Care (“RLC,” “we,” “our,” or “us”). **By requesting, scheduling, or using our services, you (“the customer,” “client,” or “you”) agree to the following Terms of Service. Please read them carefully.**

## 1. Services Provided

RLC provides lawn care and outdoor maintenance services, including but not limited to:

- Lawn mowing
- Trimming and edging
- Leaf removal
- General yard cleanup
- Other agreed-upon services

All services will be performed as scheduled and agreed upon between RLC and the client.

## 2. Scheduling & Access

- Clients must provide clear and safe access to the property on the scheduled service date.
  - Gates must be unlocked, and pets must be secured.
  - If we are unable to access the property, a service fee may still be charged.

### 3. Payment Terms

- Payment is due upon completion of service unless otherwise agreed.

### 4. Client Responsibilities

The client agrees to:

- Remove or clearly mark any obstacles (e.g., rocks, toys, wires, hoses, decorations, hidden objects).
- Inform RLC of any hazards, underground utilities, or fragile areas.
- Ensure the lawn is free of debris that could damage equipment or cause injury.

RLC is **not responsible for damage to unmarked or hidden objects.**

### 5. Property Damage Disclaimer (IMPORTANT)

While RLC takes care to perform services professionally and safely, **by using our services you acknowledge and agree to the following:**

- Lawn care involves the use of heavy and fast-moving equipment that may cause unintended damage.
- **RLC is NOT responsible for damage to property**, including but not limited to:
  - Sprinkler heads
  - Invisible dog fences
  - Outdoor lighting
  - Windows or siding
  - Decorations, ornaments, or lawn fixtures
  - Vehicles parked near service areas
  - Underground utilities or systems
- **Any damage resulting from normal lawn care operations, hidden hazards, or failure to properly mark/remove obstacles is the sole responsibility of the client.**
- **RLC is also not liable for damage caused by debris (such as rocks or sticks) being thrown by mowing equipment.**

By agreeing to these terms, you **release Riverside Lawn Care from any and all liability related to property damage.**

## **6. Weather & Delays**

- Services may be delayed due to weather conditions (rain, storms, extreme heat, etc.).
- We will reschedule as soon as possible.
- No refunds will be issued due to weather delays.

---

## **7. Service Quality & Satisfaction**

- If you are unsatisfied with a service, you must notify us within 24 hours.
- We may offer a correction at our discretion.
- Refunds are not guaranteed.

---

## **8. Right to Refuse Service**

RLC reserves the right to:

- Refuse or cancel service at any time
- Discontinue service for unsafe conditions, aggressive pets, or disrespectful behavior
- Deny service for properties deemed hazardous

---

## **9. Safety**

- Clients must keep all people and pets clear of work areas during service.
- RLC is not responsible for injuries to persons or animals who enter the work zone.

---

## **10. Limitation of Liability**

To the fullest extent permitted by law:

- RLC shall not be liable for any indirect, incidental, or consequential damages.
- Total liability, if any, shall not exceed the amount paid for the service provided.
